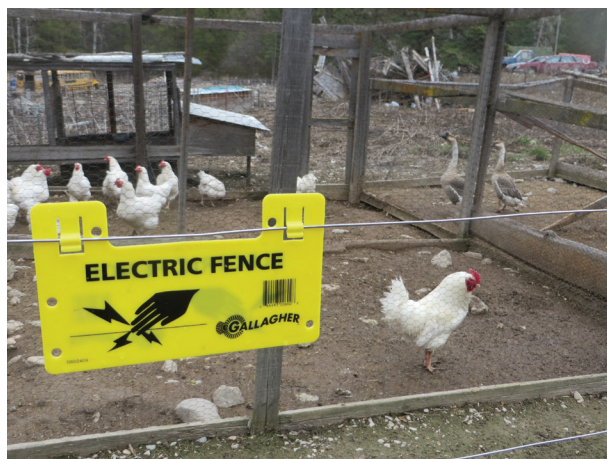

Got Bears?

Install a bear-resistant electric fence.

Defenders of Wildlife can help you pay for it.



Defenders' Electric Fence Incentive Program

Chicken coops, beehives, fruit trees, garbage and other sources of enticing odors can regularly draw hungry and curious brown bears and black bears to your property. Properly installed bear-resistant electric fencing is a simple and effective way to deter them. If you live or own property on Alaska's Kenai Peninsula or in Southeast Alaska, Defenders of Wildlife's Electric Fence Incentive Program can help you obtain an electrified barrier to keep bears out of things they shouldn't get into and will reimburse you for 50 percent of the cost—up to \$500. (Additional funding may be considered on a case-by-case basis.)

Participating in the program is a simple, three-step process:

1. See the list of qualifying bear “attractants” (opposite). If you qualify and could benefit, you must **contact us before purchasing materials and/or installing your fence** to confirm your place on our list for reimbursement. Funding is limited and first-come, first-served.
2. Plan your project. Defenders works in partnership with state and federal agencies on electric fencing and can point you in the direction of technical advice and recommendations on design and materials specific to your project. **Note that to effectively deter bears and qualify for reimbursement, your fence requires a 0.70 output joule (or greater) energizer.**
3. Once your fence is completed, fill out and submit the form (opposite) and all required supporting documentation to obtain your reimbursement.

Qualifying Bear Attractants*

- Backcountry hunting camps
- Beehives
- Boneyards/carcass pits
- Chicken coops
- Fishing camps
- Fruit trees
- Garbage
- Gardens and composting
- Livestock and pet feed
- Restaurant grease containers
- Smokers and hanging game

**Something not on this list attracting bears to your property? Call us to see if it qualifies for the fencing incentive.*
