The Defenders of Wildlife Action Fund's *2009-2010 Conservation Report Card* measures the commitment of U.S. senators and representatives to wildlife and habitat conservation during the 111th Congress. It reviews six Senate votes and seven House votes on key conservation issues, providing a clear assessment of how well members of Congress are protecting wildlife and wild lands for future generations.

The *2009-2010 Conservation Report Card* covers votes on important issues such as protecting polar bears, the world's imperiled wild feline and canine species, and California sea otters; safeguarding wildlife and habitat in sensitive borderlands; addressing the impacts of climate change on wildlife; regulating greenhouse gas emissions; upholding the Endangered Species Act; and drilling for oil off our coasts.

1 Undermining the Endangered Species Act and Polar Bear Protections

The Senate rejected an amendment that would have delayed the administrative reversal of Bush administration rule changes that weakened the Endangered Species Act and limited protections for the listed polar bear. (*March 5, 2009, Roll Call No. 82*)

2 Walling Off Sensitive Borderlands and Wildlife

The Senate passed an amendment to the FY 2010 Department of Homeland Security appropriations bill that would have required the building of at least 700 miles of reinforced fencing and doubled the number of miles of wall along the Southwest border. (*July 8, 2009, Roll Call No. 220*)

3 Attacking the Endangered Species Act

The Senate rejected a motion that would have prevented the implementation of two biological opinions protecting endangered and threatened salmon, steelhead, sturgeon, delta smelt and orcas in California under the Endangered Species Act. (*September 22, 2009, Senate Roll Call No. 292*)

4 Expanding Offshore Drilling

The Senate rejected a motion to expedite drilling in long-protected waters along the Atlantic and Pacific coasts.

(*September 23, 2009, Senate Roll Call No. 293*)

5 Harming Borderlands Wildlife by Requiring More Walls

The Senate rejected a motion to suspend Senate procedures and permit consideration of a harmful 2010 Supplemental Appropriations Act amendment that would require at least 700 miles of reinforced fencing along the Southwest border. The fencing would replace the more wildlife-compatible vehicle barriers that now form about half of the existing border wall. *(May 27, 2010, Roll Call No. 172)*

6 Blocking EPA from Regulating Greenhouse Gas Pollution

The Senate rejected a resolution that would have prevented the Environmental Protection Agency (EPA) from regulating greenhouse gas pollution under the Clean Air Act to protect the nation from the dramatic impacts of climate change. *(June 10, 2010, Roll Call No. 184)*

KEY ISSUES & VOTES

1 Funding for Great Cats and Rare Canids Conservation

The House of Representatives passed a bill authorizing funding for conservation programs to protect some of the world's most imperiled wild feline and canine species. *(April 21, 2009, Roll Call No. 194)*

2 Attacking the Endangered Species Act

The House rejected an amendment that would have prevented implementation of a biological opinion protecting endangered and threatened salmon, steelhead, sturgeon and orcas in California under the Endangered Species Act. *(June 18, 2009, Roll Call No. 366)*

3 Restoring Funding for Lands and Wildlife

The House passed a bill for 2010 fully funding the president's unprecedented increase in spending to address climate change impacts on wildlife and ecosystems and giving important direction to land and wildlife programs. *(June 26, 2009, Roll Call No. 475)*

4 Curbing Greenhouse Gases and Safeguarding Wildlife from Climate Change

The House passed a groundbreaking bill addressing climate change with a "cap-and-trade" plan for greenhouse gas emissions and provisions for planning and funding to help safeguard wildlife and natural resources threatened by climate change. *(June 26, 2009, Roll Call No. 477)*



5 Funding for Sea Otter Research and Recovery

The House passed a bill authorizing funding for federal recovery and research programs to benefit the threatened population of sea otters that lives off the coast of California. *(July 28, 2009, Roll Call No. 651)*

6 Preventing Ocean Acidification and Addressing Its Impacts

The House rejected a resolution calling on the United States to adopt national policies to prevent the acidification of our oceans caused by increases in atmospheric carbon dioxide due to climate change and to improve research on ocean acidification and address its impacts on marine ecosystems and coastal economies. *(June 9, 2010, Roll Call No. 341)*

7 Reforming Oil and Gas Regulations to Prevent Catastrophic Spills and Funding Conservation

The House passed a bill addressing the technical and regulatory failures that contributed to the catastrophic BP oil spill in the Gulf of Mexico, fully funded the Land and Water Conservation Fund, and provided hundreds of millions of dollars for Gulf of Mexico restoration. *(July 30, 2010, Roll Call No. 513)*
