Northeast Transportation and Conservation Planning Summit December 17th and 18th, 2007 Holiday Inn in Concord, New Hampshire 172 North Main St. Concord, NH 03301

<u>Summary</u>: The Maine Department of Transportation, New Hampshire Department of Transportation, Vermont Agency of Transportation, Federal Highway Administration, Henry P. Kendall Foundation, and Defenders of Wildlife are hosting a day and a half summit to identify ways to improve the connection between long range transportation planning and conservation planning. As integrating conservation and transportation planning is required by the federal legislation known as SAFETEA-LU, this summit is designed to help address the issues and opportunities which may arise throughout this process.

You will be joining 40 colleagues from each host state (120 total), including transportation and conservation planners, resource managers, non-profit organizations, and others to discuss opportunities for transportation and conservation inter and intrastate collaboration. The workshop will emphasize the use of information, tools and methods that can be shared between the transportation community and the resource and regulatory agencies at the local, state, regional, and national levels.

The first day's discussion will focus on the basics of conservation and transportation planning. The second day will be used for individual state break-out sessions, where state-specific practices, success stories, and ideas can be discussed. At the conclusion all participants will rejoin each other to share conclusions, and to discuss how to best move forward.

Thanks to the generous support of the Henry P. Kendall Foundation, your expenses, to include meals, hotel and mileage, will be covered. Reimbursement forms will be provided at the summit.

We hope you will join us in this exciting opportunity to improve transportation and conservation planning in our states. The event is invitation-only and space is very limited. If you are unable to participate and wish to designate someone from your organization, please do so.
